CISRS Scaffolder CPD/ Refresher Training Course



Course Duration: 2 Days

From 1st July 2017, it is a requirement of the CISRS scheme, that CISRS Scaffolders and Advanced card holders must attend a 2-day Scaffolder Refresher/CPD Course in order to renew their cards. The CPD course has been developed to refresh the delegates existing knowledge. This will ensure the delegate is made fully aware of changes in legislation and good working practices, receive additional training and align their skill set with the contents of the current CISRS Scaffolder and Advanced Scaffolder courses.

This course will help ensure that CISRS Scaffolders/Advanced scaffolders maintain their status of being fully trained, safety compliant and highly respected within the construction industry.

Aims and Objectives:

- To meet the requirements of the HSE regarding Continuing Professional Development
- To comply with the requirements of the CDM Regulations
- To give attendees an update on current industry best practice
- To ensure all scaffolders and advanced scaffolders have received the necessary information regarding industry best practice and current legislation regarding the activities associated with the scaffolding industry.

Scaffold Inspection Module:

To pass the scaffold inspection module delegates will be required to complete the practical test and correctly answer a minimum of 7 questions out of 10 in the theory test. Delegates who pass the scaffold inspection test will have their renewed card endorsed accordingly. Delegates who hold a separate inspection card will no longer be required to renew this separate card.

Mobile Access Tower Training for Scaffolders (MATS):

To pass the MATS module, delegates will be required to complete the practical element of the course and correctly answer a minimum of 11 questions out of 15 in the theory test. Delegates who pass the MATS test will have their renewed card endorsed accordingly.

Scaffolding Health, Safety & Behavioural Test:

To pass the scaffolding Health, Safety & Behavioural test delegates will be required to correctly answer 41 questions out of 50. Delegates who pass the test will be able to have their card renewed. Delegates who fail this test will be required to pass a CITB Health, Safety & Environmental Test or hold a recognised exemption in order to apply for their new card.

Delegate Course Materials:

All delegates will be provided with a printed copy of the CISRS Health, Safety and Behavioural Test Revision Booklet with their course joining instructions. Delegates must be advised to carefully read this document and that it must be brought to the course.

All delegates will be given an original CISRS Scaffolder Refresher/CPD folder during the course induction.

Absenteeism:

Delegates who miss either of the days training will be deemed to have failed the course and will have to attend a further full 2-day course.

Pre-requisites for Candidates:

The Scaffolder CPD/Refresher Training course is only available to CISRS Scaffolder and Advanced Scaffold card holders.

Delegates are eligible to attend the course up to six months in advance of their card expiry date. Their new cards will expire five years after the expiry date of their existing card. For delegates who attend the course after their card has expired, the expiry date will be five years from the card processing date.

Literacy and language comprehension are important requirements on all courses. Any physical impairment or literacy issues should be discussed with LTC Training Services Ltd prior to making a booking so we can best accommodate your needs.

Training Location Options:

Due to the nature of this training course i.e. that it involves the physical erection of MATS it is held only in our CISRS Accredited Training Centre located at our head office in Plymouth, Devon and our centre in Cullompton, Devon.

Course Start Time:

Course starts at 8.15am and finishes at approximately 5.00pm each day.

Certification/Card Application:

LTC Training Services Ltd will issue a certificate to all delegates who have completed the course. The certificate will also indicate whether the delegate has passed or failed the Alloy Tower, Scaffold Inspection and HS&B Test modules (it should be noted that no re-sits of tests will be allowed). They will be forwarded to the customer once payment has been received in full. The certification for this course has no expiry date, however this course will need to be carried out every five years when the candidate is required to renew their scaffolder/advanced scaffolder card.

LTC will apply for all cards.

As previously stated, should a delegate fail the HS&B Test, LTC Training Services Ltd will still be responsible for the card application. In these circumstances delegates will be required to pass a CITB Health, Safety & Environment Test or hold a recognised exemption in order for the card application to be made.

Equipment:

You will be required to wear PPE (Personal Protective Equipment) during the practical aspects of the course, this will include hard hat, safety footwear, gloves and a high visibility vest/jacket.

Lunch and Refreshment Facilities:

Lunch is included at no extra cost. Water, tea, coffee, fridge and microwave facilities are also available in our canteen for use your use free of charge.
