Emergency First Aid at Work EFAW



Course Duration: 1 Day

Employers' Duties on First-Aid Training:

The Health and Safety Regulations 1981 require employers to provide suitable first-aid equipment, facilities and personnel so that immediate assistance can be given to employees if they are injured or become ill at work. The regulations state that in order to provide first-aid, a person isn't suitable unless they have undergone:

- The right training and qualifications approved by HSE; and
- · Any additional training if required

Aim and Objectives:

If a company decide they don't need a first-aider in their workplace (A FAW – First Aid at Work trained person), then the minimum requirement is to appoint someone to take charge of first-aid arrangements. The role of this 'Appointed Person' includes looking after first-aid equipment and facilities and calling the emergency services when required. They can also provide emergency first-aid cover where a first-aider if absent due to unforeseen circumstances (annual leave does not count). Appointed persons do not need first-aid training, though emergency first-aid courses are available and advisable.

Even if you decide first-aiders are unnecessary in your organisation, there is still the possibility of an accident or illness, so you may wish to consider providing qualified first-aiders. Appointed persons are not necessary where there are an adequate number of first-aiders.

Course Content:

Understand the role of the first-aider including reference to:

- The importance of preventing crossinfection
- The need to record incidents and accidents
- Ability to assess the circumstances and situation in order to act safely, promptly and effectively in an emergency
- Administer first aid to a unconscious casualty (including seizure)
- Administer first aid to a choking casualty
