IPAF Add On Category



Course Duration: 1/2 Day

Aim and Objectives:

This course is for operators who want to add an additional machine category to their IPAF operator qualification.

Candidates must successfully complete the IPAF approved theory test paper. In addition to this, they must achieve the required standard when operating each of the machine categories that they wish to add to their IPAF qualification.

If demonstrators want to add a category to their PAL Card, they must do the operator theory test and practical test on that category, then do the demonstrator course.

Objectives:

At the end of the course the operator will:

- Be aware of the relevant health and safety regulations
- Be aware of the needs regarding personal protection
- Be aware of the need to refer to the machine operating manual

Course Content:

- Introduction and housekeeping
- MEWP categories
- Structural parts
- Regulations
- Pre-use inspections and handovers
- Safe operating methods and hazards
- Theory test
- Practical training
- Practical assessment
- Licence renewal
- Course evaluation

Machine Categories:

The IPAF machine categories are as follows:

3a – Mobile Vertical

3b - Mobile Boom

1b - Static Boom

Candidates must hold a valid IPAF operator qualification and be able to produce their IPAF 'PAL' card for inspection by our training instructor prior to course commencement.

Certification:

IMPORTANT - Please note: All candidates who undertake IPAF training and pass will get their license and/or certification through IPAF's new app, **ePAL**. In addition, the Co-ordinator of the booking will receive a digital copy once payment has been received in full.

The app is available on iOS and Android apps (search ePAL) and we request that delegates download this app to their smart phone ahead of the course.

The training is valid for 5 years.

Equipment:

Candidates are required to wear appropriate PPE (safety footwear, hard hat, gloves, safety harness and hi-viz jacket or vest). Candidates should also bring wet weather clothing in case of inclement weather and should wear full length trousers (no shorts). Writing materials will be provided. Candidates who do not have any of these items should make us aware of this at the time of booking.

Lunch and Refreshment Facilities:

Lunches will not be provided. However water, tea, coffee, fridge and microwave facilities are also available in our canteen for your use free of charge.

Accommodation and Transport:

Candidates are required to organise and pay for their own accommodation and transport should it be required. A list of local accommodation can be provided on request.

Refresher Training:

IPAF have produced a renewal course for candidates who have already completed IPAF operator training and have continued to use MEWPs regularly in the 5 years they have held their qualification.

The renewal course must be taken before the original training expires. Candidates must also be able to provide their log book with a minimum of 60 entries (10 of which must be in the final year prior to expiry) as proof of their continued machine use. Please see the 'IPAF renewal and upgrade' course description for further information.

Candidates who don't meet the requirements for the renewal course can attend the operator course again.
