CISRS Scaffolding Part 1

Course Duration: 2 Weeks



Candidates must hold a valid CISRS Trainee Scaffolder or CISRS Scaffolding Labourer card for a minimum of 6 months before attending a CISRS Scaffolding Part 1 course. Candidates must also have a minimum of 6 months practical experience of scaffolding operations (e.g., Labouring, carrying out simple scaffolding operations under the direct supervision of a qualified scaffolder). See the CISRS Training Flow Chart or contact us for further information.

The law requires that any individual wishing to erect, alter or dismantle scaffolding must be able to prove their competency. The industry-wide accepted proof of competency for operatives is to hold a CISRS scaffolder card.

To be eligible to apply for this card, candidates must successfully complete the following elements of training;

- 1. CISRS Scaffolding Part 1 course
- 2. CISRS Scaffolding Part 2 course
- 3. Level 2 NVQ Diploma in Accessing Operations and Rigging (Construction) Scaffolding
- 4. CISRS 1 Day Skills Assessment

Certification for all of the above courses will need to be attached to your CISRS scaffolder card application form for it to be issued. See the relevant course descriptions and our training route flowchart for further information.

The CISRS Scaffolding part 1 course is suitable for adult trainees who want to work towards achieving a CISRS scaffolder card and level 2 NVQ diploma in accessing operations and rigging (construction) scaffolding. Following completion of the part 1 course operatives will have been trained to erect and dismantle basic scaffolds as listed below. Operatives can apply for a CISRS trainee scaffolder card once they have passed a construction skills health, safety and environmental test. Following completion of the course operatives will need to gain a minimum of 6 months scaffolding experience before attending the CISRS scaffolding part 2 course also held at LTC Training Services Ltd.

Candidates must also attend and successfully complete the CISRS 1 Days Skills Assessment and level 2 NVQ Diploma in Accessing Operations and Rigging (Construction) Scaffolding as certificates for all of these elements of training will be required when applying for a CISRS scaffolder card – all of which can be completed at LTC Training Services Ltd.

Aims and Objectives:

The part 1 course is designed to train suitable candidates to the objectives approved by CISRS in the safe erection, alteration and dismantling of the following types of scaffold:

- Independent
- Independent with return
- Mobile aluminium towers
- Static tower
- Putlog scaffold and staircase
- Birdcage

By the end of the course delegates will be trained to:

- Select, inspect and erect scaffolding structures up to 3 lifts (6m)
- Interpret and apply relevant current regulations and codes of practice
- Select and inspect scaffold materials for their serviceability
- Select the correct quantity and type of components required

Pre-requisites for Candidates:

Since the 1st September 2015 Candidates must hold a valid CISRS Trainee Scaffolder or CISRS Scaffold Labourer card for a minimum of 6 months before attending Part 1. We will require a copy of their CISRS Card (or registration number) for verification purposes prior to the candidate booking their course.

Candidates must also have a minimum of 6 months practical experience of scaffolding operations (e.g. labouring, carrying out simple scaffolding operations under the direct supervision of a qualified scaffolder). Candidates must also complete and return to LTC Training Services Ltd a health questionnaire (must be returned 21 days prior to starting the course).

Literacy and language comprehension are important requirements on all courses. Any physical impairment or literacy issues should be discussed with LTC Training Services Ltd prior to making a booking so we can best accommodate your needs.

Training Location Options:

Due to the nature of this training course i.e. that it involves the physical erection of live scaffold structures it is held only in our CISRS Accredited Training Centre located at our head office in Plymouth, Devon.

Course Start Time:

Course starts at 8.00am and finishes at approximately 5.00pm each day.
