# **CITB Health and Safety Awareness**



# **Course Duration: 1 Day**

This course is for those who have entered, or are about to enter the construction and civil engineering industry as a member of the workforce, and is designed to aid the understanding potential hazards the construction worker may face on site.

It provides a practical summary of health and safety, welfare and environmental issues. It identifies the delegate's responsibilities for looking after themselves and others, outlines the employer's duties and explains what should be done if the worker thinks that anyone's health and safety is being put at risk.

The course is an ideal foundation for those wishing to obtain an industry site card.

It is also an alternative route to the QCF Level 1 Award in Health and Safety in a Construction Environment for the CSCS Labourers Card.

<u>Please Note:</u> You will need to complete this course (in addition to completing a CITB Health, Safety & Environmental touch-screen test) if you wish to apply for a new CSCS Green Labourer Card. It is recommended that you attend the CITB H&S Awareness course first, as it will assist you with the touch-screen test.

#### **Course Publication:**

The course publication is the pocket-sized Safe Start Safety Handbook GE707. A copy is included in the course fee and publications should be retained by candidates for future reference.

The handbook has also been written to assist operatives sitting the CITB-Construction Skills Health, Safety and Environmental Test.

#### **Assessment:**

The method of assessment will be by 25 multiple-choice questions: 20 questions are worth one mark each and 5 questions worth two marks each. Delegates must obtain 25 marks out of 30 (83%) or more in order to pass the examination.

For a delegate to obtain certification for this course they must pass the HSA examination. The examination lasts 30 minutes and must be completed within this time. This is a closed book exam.

Candidates are also expected to be interactive during the course.

#### **Pre-Requisites for Candidates:**

It is a CITB requirement that all delegates attending Site Safety Plus courses MUST bring some form of photographic identification with them on the day of the course (or prior to the examination for courses of more than 1 day).

Where identification evidence is not provided by the delegate, they will be refused attendance on the course

No formal qualifications or experience are necessary.

Literacy, language comprehension and numeracy are important requirements on all courses.

Any physical impairment or literacy issues should be discussed with LTC Training Services Ltd prior to making a booking so we can best accommodate your needs.

### **Training Location Options:**

We offer this course from our Devon and Cornwall training centres as well as giving customers the option to hold training on site at a location of their choice (subject to minimum candidate numbers and the proposed venue having a suitable classroom facility and any other necessary facilities required for this course). # Course Start Time:

Course starts at 8.15am and finishes at approximately 5.00pm each day.

#### **Certification:**

Certificates are included in the cost of this course and are produced by CSkills Awards.

CITB recently announced that from 7<sup>th</sup> December 2020 all Site Safety Plus certificates will be sent to Training providers as digital PDF's. For all SSP courses, the default delivery method for certificates will now be digital, meaning hard copy certificates will not be sent.

We must allow up to 10 working days for production. They will be forwarded to the customer once payment has been received in full. Certificates are valid for 5 years.

#### **Refresher Training:**

There is no refresher available for the one-day Health and Safety Awareness course. Candidates will be expected to attend a new course prior to their certificate expiring.

#### **Equipment:**

Candidates are not required to bring any special equipment. Writing materials will be provided.
