## **Certification:**

We must allow up to 10 working days for production. They will be forwarded to the customer once payment has been received in full. Certificates are valid for 5 years.

### **Refresher Training:**

Although certificates are valid for five years, due to continuing changes in legislation, technology, environmental management and cultural behaviour, it is recommended that the SSSTS 1 Day Refresher course is undertaken within three years of completing the original SSSTS course.

Candidates must take a SSSTS Refresher course *before* their existing certificate expires, otherwise the full SSSTS course will have to be taken again.
